Terms and Conditions

1. This constitutes an exclusive contract for wedding photography. It is understood that all images taken by the photographer(s) remain the property of the photographer(s) and are protected under United States copyright laws. They may be used in advertising, display, promotion or any other purpose thought proper.
2. This contract includes _____ hours of time. Start time: _____ am pm. End time: _____ am pm
If needed, additional time may be added at \$100 per hour. Note: More than two hours over the time stated above will result in an automatic upgrade to the next higher coverage and contract price will be adjusted accordingly. Does not apply to packages with unlimited coverage.
3. Delivery: 1. If only the rights to print the digital files are purchased, the files will be delivered on a CD/DVD within two weeks after the wedding. 2. If a package without an album is selected, proofs will be delivered within four weeks after the wedding. 3. If an album is purchased, we will have the album layout ready for preview with proofs by the client four to six weeks after the wedding. Depending on which album is selected the final album will be delivered from eight to twelve weeks after the preview session.
4. Although the utmost care will be taken with the digital files, the photographer limits any liability for the loss, damage or failure to deliver the pictures for any reason to the return of all payments made.
5. Upon signature of this contract and receipt of the "reservation fee" of \$350, the photographers reserve the time and date agreed upon, and will not make other reservations for that time and date. For this reason, the reservation fee is not refundable, if the date is changed or the wedding is canceled for any reason.
6. Payment for services (check one).
 - Normal – One half of the package price (less \$350) is due six weeks prior to the wedding date. The remaining one half, less \$350 reservation fee plus sales tax, if applicable, must be paid in full one week before the wedding date.
 - Budget Plan – One third of the package price is due two months prior to the wedding date, the next third due two weeks prior to the wedding and the remaining third, less \$350 reservation fee, plus sales tax is paid upon delivery of finished goods or services.Failure to make payments by the dates indicated above constitutes a breach of contract and unless other terms are agreed upon by both parties, the photographer will not photograph the wedding. All payments must be made before, or at the time of delivery of the goods and/or services included in this contract.
NOTE: Missouri State Sales tax of 6.575% will be added to all orders.
