- An online preview gallery divided into "chapters" covering your wedding day.
- 4X6 photos, in a box. Optional binder available at additional charge.
- A designer "flush mount" album made up of 10X10 images or a library bound matted album.

**Photographic coverage** -- \$125.00 per hour of coverage (minimum of 2 hours)

### **DVD with rights to print the images taken at your wedding!**

The high resolution digital files of the images taken at your wedding are burned onto a DVD.

## *Additional Information*

**Pre wedding planning session:** A pre-wedding planning session is suggested to discuss specific details of the wedding schedule and photography. This session is at the discretion of the couple and the photographers and is optional.

**Photo selection, preview and delivery:** If your wedding package includes an album, once the original prints are received back from the photo lab we select the photos that best “tell the story of your day” and lay out an album. We then contact you and schedule a “preview session.” At the preview session you review our selection of prints to include in the album as well as select the album type, cover color, page and mat style. You may change any print you wish at the time of the preview. After the preview session, your album and enlargements are ordered and assembled. The finished album is delivered to you in approximately eight to ten weeks after the preview session. If a flush mount album is chosen, another preview will take place either of the Internet or setting up an appointment to view the actual photographs before they are bonded onto the album pages. At the time of delivery you review your album and if satisfied, take it home to share with family and friends. If you are not satisfied we will change any print you wish changed in the finished album. We offer a 100% satisfaction guarantee.

**Payment for services:** In order to secure a specific date for your wedding photography we require a non-refundable “reservation fee” of \$350. Depending on which payment plan is selected, one-third or one-half the cost of the package, less the reservation fee, is to be paid at least six weeks prior to the wedding date. Under the “normal” payment plan the remainder of the charges are due and must be paid in full no later than one week before the wedding date. Under the “budget” plan the second of three payments must be made one week before the wedding day.

**Publication Rights:** According to United States copyright law, all rights to a photographic image belong to the photographer from the moment the photograph is taken. Unless otherwise agreed upon, the copyright of all images taken by the photographer(s) of your wedding remain the property of Rau Imaging, Inc. It is therefore a violation of U.S. federal law to make copies or digital scans of any prints delivered to you the client by any means for a period of fifty years. If you would like to have an image reproduced on invitations, novelties or used in a video presentation, please secure permission from us. Unless otherwise agreed to, all digital files remain in the possession of Rau Imaging, Inc. and will be kept for a period of five years. If a CD/DVD is purchased, then this statement appears on the case of the CD/DVD: “Rau Imaging, Inc. recognizes and agrees that the Client may reproduce the wedding day images contained in the enclosed CD/DVD for personal, non-commercial use including the reproduction of copies for family, wedding guests, relatives and friends. The images may also be used in electronic “slide-shows” or on computer screen savers, etc. They may also be used in the publication for wedding related newspaper announcements or articles provided that images carry a credit line. Client will not permit any commercial use or sale of the images without specific consent of Rau Imaging, Incorporated.”

We are a Kodak “*Promise of Excellence*” studio. This means we employ the services of a local professional lab to print the images taken at your wedding with Kodak processing chemicals and Kodak papers. This assures you of both quality and longevity for your treasured photographic memories.
